SECTION 4: First aid measures

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation : At high concentrations, the vapours can be irritating to the respiratory system.

Symptoms/effects after skin contact : Repeated or prolonged contact may cause allergic reactions in very susceptible persons. Symptoms may include skin rash, inflammation, redness, itching, swelling and similar
